Waiver, Release of Liability, and Assumption of Risk (Read before signing)

In consideration of the services of Las Vegas Canoe Kayak Club, its members, their agents, owners, officers, volunteers, participants, employees and all other persons or entities acting in any capacity on their behalf (herein collectively referred as "LVCKC".):

1. I understand and hereby acknowledge that my participation in paddling a canoe, kayak, surf ski, or paddle board entails risks that are known, unknown, anticipated, and/or unanticipated that could result in physical injury, death or damage to myself, property, or to third parties. I understand that such risks cannot be eliminated without jeopardizing the essential and/or fundamental nature and quality of activity on open water. I assume those risks and release LVCKC from liability resulting from those risks. I understand that I am hereby relinquishing certain legal rights.
2. I understand and acknowledge that LVCKC and seeks safety as its first and paramount concern, but is not infallible. It might be unaware of a participants fitness/abilities or it might misjudge the weather and, as a result, it may give inadequate warnings or instructions. I also understand that the equipment being used might malfunction. I assume those risks and release LVCKC from liability resulting from those risks. I understand that I am hereby relinquishing certain legal rights.
3. I understand and acknowledge the nature and risks of a canoe, kayak, surf ski, and paddle board paddling and I represent that I am qualified, in good health, and in proper physical condition to participate in such activity. I agree that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation of the activity.
4. I agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
5. LVCKC being on City of Henderson land, this agreement applies to any negligence alleged against LVCKC and/or City of Henderson: I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless LVCKC and the City of Henderson from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of LVCKC's equipment or facilities, including any claims which allege negligent acts or omissions by LVCKC or the City of Henderson. The risk of any medical or physical condition I may have.
6. I represent that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in this activity. Alternatively I agree to bear the costs of such injury or damage myself. I agree that I assume

I hereby grant to LVCKC, as agents and assigns the right to use photos and /or other digital reproduction of me or other reproduction of my physical likeness for publication processes, whether electronic, print, digital or electronic publishing via the internet. This authorization shall remain in effect until revoked in writing and delivered to the LVCKC.
8. Damages: I hereby agree to pay for a missing SUP or kayak \$800.- , for a missing paddle \$200.- , cracked or punctured hole repair on SUP/kayak \$200.- .

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against LVCKC and/or the City of Henderson on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understand it and I agree to be bound by its terms.
